

Biden is a Criminal

The other day Biden extended the federal eviction moratorium. By his very own words he said that it was probably not legal, yet he went ahead in spite that the Supreme Court also declared the moratorium illegal.

In other words, Biden broke the law by issuing an unlawful order. This is not the first time he did this. Biden also issued illegal orders to US Customs and Border Protection to stand-down with regard to illegal immigrants entering our nation.

Now one might say, "Wait a minute, it was the CDC which issued the moratorium." Well that is absolutely true. The CDC did issue the moratorium order, however Biden supported it. Okay, you may say but that doesn't make any difference.

Again you are right, it does not matter whether the CDC issued the order or if Biden did. The fact is that Biden is responsible for the actions of those below him. In other words he appointed the director of the CDC and thus is responsible for her actions as well

You may say, "No he is not responsible for her actions," but remember; he himself announced support for the moratorium and at the same time questioned its legality.

Why is this important to know? From 1945-1946, German military personnel used what today is called the "Nuremberg Defense," "I was just following orders." This was not the first time in history that this defense was used. Earlier precedents of this defense date back to the Napoleonic Wars (1803-1815), the War of 1812, the Mexican-American War (1846-1848), along with many other incidents.

While the Nuremberg Trials concerned genocide, the US government, the Hague, the United Nations, along with many nations have developed laws, rules and regulations that prohibit such a defense and allows a person to refuse to obey unlawful orders.

Articles 90-92 of the Uniform Code of Military Justice (UCMJ) discuss obeying lawful and unlawful orders. Most states have statutes that address both civilians and law enforcement personnel following lawful orders.

The basis for following or not following orders, lawful or not is the US Constitution. While disobeying unlawful orders is grounded in military and law enforcement, it also applies to civilians and politicians.

For example, the “Fourth Geneva Convention” prohibits a wide array of attacks targeting civilians (particularly articles 27, 31, and 33). Since the US is a signatory of the Convention, it must also obey the Convention with regard to its own citizens.

Since Biden has issued orders contrary to the Convention, he is violating international law in addition to the US Constitution. As “Commander-in-Chief” of the military, any orders that Biden issues MUST be legal. While most people believe this applies only to the military, it also applies to the American population. Hence, a national mandate to wear masks or get vaccinated is illegal because such orders violate the fourth, fifth, sixth, seventh, eighth and ninth amendments to our Constitution.

While Biden is the “head” of his administration, he is also responsible for the actions of those in his cabinet along with other government personnel he appoints or others he give the authority to appoint. For example, the director of the CDC is also violating the same laws (no eviction mandate) as Biden and may also be doing Biden’s will by obeying an unlawful order.

Biden and his ilk are placing themselves above international and US law, the US Constitution, and the ethics and morals of common decency. The process they follow is to issue some form of an order, edict or mandate that they know is illegal or at least suspect it to be illegal, and then wait to see if anyone challenges it in court. The media, in its stupidity and as agents of the administration, tries to downplay the legal issues of these orders.

The non-eviction mandate, and the push by congressional members and some governors to quarantine or isolate non-vaccinated citizens, violate our laws and the Geneva Convention.

It is important that when we see that something is wrong to **speak up** and **act** to stop whatever is wrong. In 1938, the German people, failed to do this with regard to the country’s and Europe’s Jewish population, and the result was that 2 out of every 3 Jews died in concentration camps from medical experiments, gas chambers, burned to death in ovens, or otherwise killed.
