

The CDC Spy Operation

In a recently FDA press release the FDA stated that the “monovalent Moderna and Pfizer-BioNTech COVID-19 vaccines are no longer authorized for use in the United States.” A week prior to FDA’s announcement, Biden signed a bipartisan congressional resolution that brought an end to the COVID national emergency.

For many people the above can be called “good news.” However the COVID pandemic in the US has many dark sides. One of those sides has been CDC’s implementation of a “spy operation.” NO, this is not a conspiracy theory but an actual event of a national health agency spying on Americans. Let’s look into this for further understanding.

Let’s first define, “What is a spy operation?”

The practice of spying or using spies to obtain secret or confidential information about the plans and activities of a foreign government or a competing company.

The act of obtaining secret or confidential information. A person who commits espionage is called an espionage agent or spy. Any individual or spy ring (a cooperating group of spies), in the service of a government, company, criminal organization, or independent operation, can commit espionage. The practice is clandestine, as it is by definition unwelcome.

British Intelligence (MI5)

Whenever there is an outbreak of some disease, medical and health officials want to find where these outbreaks began and who the initial “disease carrier” was. In the past, the carrier was referred to as “Patient Zero.” In the 1906 Typhoid outbreak, patient zero was traced to a cook by the name of Mary Mallon.

In the late 1800s, health clinics began tracing the partners of patients who became infected with STDs. This was done to prevent the spread of STDs in the general population. The practice of finding “patient zero” still continues to this day.

In 1988, the term “patient zero” took on a negative connotation as the public stigmatized the person who brought HIV into the US. Consequently the CDC redefined the entire

process of finding patient zero by referring to an outbreak as a case and then classifying patient zero either as:

- **Index Case** – the first reported case of a disease diagnosed by clinician or epidemiologist
- **Primary Case** – a person who gets the disease from an exposure and is the first case in the population

Regardless of who the first person was, the process is very much like solving a law enforcement case. This practice is still pursued around the world by health agencies and medical professionals.

However, with COVID-19, the CDC created a spy operation, that until recently, the American public was largely unaware of. There were two very significant aspects of this operation.

1. The first aspect was requiring health/medical facilities to report COVID cases to the CDC. This requirement was in addition to reporting adverse effects of the vaccines (the VAERS program).
2. The second aspect involved the CDC initiating new medical codes used to **track people** who have or have not been vaccinated, and those who are under vaccinated. Keep in mind that this process actually created a database with people's names and addresses. The CDC database, according to CDC, was tied to healthcare and medical databases.

After being confronted by the media, the CDC now states that they “don't have access to the data, but that healthcare systems do.” IMHO this is a completely false statement for several reasons.

- It is government practice not to destroy any “historical” information/data. Thus the database that was used to collect the information still exists and is accessible by the CDC.
- Although not publicized, most government agencies have “backdoors” into databases that they have hooked up with.
- Healthcare providers probably still provide the data to the CDC. The reason for this statement is that each time you visit your healthcare facility, you are still asked the standard COVID questions being in contact with someone with

COVID, if you have been out of the country for the past two week, questions of how you feel, etc.

There is not doubt that this CDC tracking program spies on the American people. While it is not currently public information, we can easily presume that the CDC database collects more information than it claims to. For example, we can assume that in addition to name and vaccination status that the CDC also collects information on:

- Sexual orientation
- Marital status
- Religious preference
- Ethnicity
- Your entire medical history
- Psychological/Mental state of mind (remember those drawing for a clock and words to remember)
- And anything else that may be in your medical records that you want kept private

During the COVID pandemic, the CDC and NIH have both been cloaked in a veil of secrecy, misdirection, and misinformation, which continues to this day. The CDC claims that the vaccines are safe and can be used on children from 10 years of age on up. Yet, they continue to list the initial adverse reactions (unsafe) and have not listed many of the long-term effects that are coming to light.

With regard to ALL government actions we need to follow Ronald Reagan's distrust of the government when he stated the nine most terrifying words in the English language –

I'm from the government, and I'm here to help.

NOT SO! Fight the corruption and spying!
