ACTIONS OF THE PRESIDENT OF THE UNITED STATES

WHEREAS, Joseph Robinette Biden, Jr., President of the United States of America, has failed in his duties as **president** to “Protect and Defend the Constitution of the United States against all enemies, foreign and domestic “

WHEREAS, Joseph Robinette Biden, Jr., President of the United States of America, has failed in his duties as “**Chief executive**” to insure domestic tranquility through malfeasance and inappropriate use of Executive Orders in order to cause physical, economic, and financial harm to the citizens of the United States of America.

WHEREAS, Joseph Robinette Biden, Jr., President of the United States of America, has committed the above failures with intent and resolve.

WHEREAS, Joseph Robinette Biden, Jr., President of the United States of America, with intent, malice, and resolve, has taken actions resulting in economic chaos, financial indebtedness, personal hardship, and increased criminal behavior for the nation and its people.

BE IT RESOLVED, by the citizens of the United States of America, that Joseph Robinette Biden, Jr. be held responsible and accountable for:

- a) Abuse of power
- b) Malfeasance,
- c) Dereliction in the performance of duties,
- d) Failure to maintain the security of the nation, and
- e) Bringing dishonor to the Office of the President, and to the republic
